
The local economic climate has been strong, especially in the real estate arena. Home sales and construction in all areas of Madera County continue to be robust. providing strong earnings for construction workers as well as realtors, lenders, and other support services. Chowchilla is experiencing solid commercial, industrial, and retail growth as developers are taking notice of its strategic location. Madera is experiencing the same type of growth, slowed down only by supply chain and a few regulatory issues. All of Madera's industrial parks either have new buildings under construction or are experiencing new tenant occupancy. The SR 41 corridor, just north of the San Joaquin River, is continuing to see strong real estate and retail growth that follows population increases. We anticipate off-the-chart increases in population in this area due to quality planning and access to services. Production agriculture has and will experience economic pressures due to drought conditions as well from the effects of the State Groundwater Management Act implementation. The offset will be the eventual sustainability of our groundwater basin that will allow agriculture to remain strong and effective, albeit on a diminished scale. Overall I remain bullish for our future, as Madera County remains a great place to live, work, and recreate. God Bless!




Prospects By Industry

HIGHLIGHTS

Fire Station No. 58 is the newest fire station to be built in the City of Madera. The project was funded by Measure K. The station is located southwest of Aviation Drive and Condor Avenue. The station will host three full-time personnel who will staff the station 24 hours a day, 365 days a year.

opened its doors in Fall 2020, hosting
approximately 2,000 students, providing much
relief to the other two high schools in town.
The project sits on 57 acres. The new facility
includes an integrated School-Based Health
Center in partnership with Camarena Health.

New Business

Tractor Supply opened a new retail store in Oakhurst in the Fall of 2020. The new business is located in a vacant lot on Highway 49, providing approximately 15 employment opportunities. Tractor Supply is a retail chain that carries home improvement, agriculture, lawn and garden maintenance, livestock, and pet care.

EZ Trip Travel Plaza → opened in Madera off of Highway 99 and Avenue 12. The location offers eateries such as Cinnabon and Subway, dozens of fuel stations, and charging stations for electric vehicles. The center created around 70 employment opportunities.

47 Twelve Macarons a family-friendly business opened in Summer 2021 in Chowchilla. The dessert shop offers macarons, tea, coffee, Salvadoran treats, and a nook for reading or performing.

In Chowchilla, Stacey and Kendra Gardner are sisters and the owners of **Lady G's Soul Spot**. The restaurant serves southern American comfort food and is located off Robertson Boulevard in the Town & Country shopping center.

Sugar Ray's BBQ opened in the spring of 2021 in Chowchilla, serving mouthwatering barbecue dishes. The restaurant is located at 720 Roberston Boulevard.

Vallarta Supermarket

Vallarta Supermarkets ↑ opened in the Fall of 2020 in Madera. The largest Latino-owned supermarket chain in California has renovated the formers Mervyn's location and hired over 200 employees.

Flightcraft Boats USA opened in Chowchilla in Fall 2020, sharing a location with Bravo Sons Auto Center located at 1677 Roberston Boulevard. The dealership provides financing for both new and used boat crafts.

Fairfield and Hampton Inn, Oakhurst, CA: two hotels recently opened their doors in Spring of 2021, located in a prime opportunity zone for travel along Highway 49.

O'Reilly's Auto Parts opened a new retail location in Madera Ranchos in Spring 2021. The new business is located on Avenue 12 and provides residents with auto parts and a variety of services such as free battery testing, check engine light testing, and more.

Expansions & Ground Breaking

Sealed Air currently is working on a 12-acre solar array to power their existing facility and allow for more expansion. They have added approximately 40 employees in the past year.

California High Speed Rail grade separation at Avenue 12 was completed in Fall 2020.

Madera Community College breaks ground on the Academic Village II. The \$35 million project is funded by Measure C bonds. The new academic village will add general education classrooms and lab space, and is expected to be completed by Summer 2022 and open to students the following Fall.

Joe's Premium Car Wash broke ground in Spring 2021 in Chowchilla on the corner of Robertson Blvd and Ave 26. This project will be family-owned-and-operated, bringing to Chowchilla its very first automated car wash.

Camarena Health ↑ broke ground on its newest location in the Tesoro Viejo community. The project is expected to be completed in 2022 and equipped to provide a wide range of medical services for the community.



Updates

After a long wait, the **North Fork Rancheria Resort & Casino** \checkmark continues to make progress in its development. It is expected to be completed in 2024.

Full Throttle Suspension continues to move forward. At completion, the facility will be approximately 101,120 sq ft.

In early 2021, Pacific Ethanol changed its name to **Alto Ingredients** and was sold for \$28.3 million to Seaboard Energy Calilfornia, LLC. Seaboard operates plants to produce biodiesel, renewable natural gas, and compressed natural gas.

MESSAGE FROM THE DIRECTOR





Cal Recycle's Recycling Market Development Zone

CalRecycle's Market Development Zone (RMDZ) program combines recycling with economic development to fuel new businesses, expand existing ones, create jobs, and divert waste from landfills. This program provides attractive loans, technical assistance, and free product marketing to businesses that use materials from the waste stream for their manufacturing. To participate, a business must be located in an RMDZ Zone. All of Madera County is an RMDZ zone so businesses within the county automatically are given the opportunity to benefit from the RMDZ program.

Foreign Trade Zone

A U.S. Foreign Trade Zone is a designated area that is, for Customs purposes, considered to be outside of the United States. Nearly any imported merchandise can be brought into a Foreign Trade Zone duty-free

Opportunity Zones

Are federal economic development tools aiming to improve the outcomes of distressed communities. They offer tax incentives to groups who invest and hold their capital in zone assets or property for at least five years and permanent exclusion from a tax on capital gains from the opportunity investment held for ten years. Madera county has five designed census tracts included.


