## Message from the Chairman



Hi friends! 2022 proved to be another challenging year for certain sectors of the Madera County business community and provided growth opportunities for others. The rise in interest rates, increased by the Fed to curb inflation, significantly slowed

down residential construction and sales as fewer people were able to qualify for mortgages. Builders and developers took this opportunity to increase the number of lots available for future construction, and home prices have retreated only marginally due to the continued shortage of stock available. Unfortunately, production agriculture continues to experience economic pressures due to drought conditions and almond prices to the grower that in most cases don't cover the cost of production. Adding insult to injury are increases in costs caused by inflation and rising interest rates. The good news is that the industrial sector is still showing strength within our existing businesses as well as new businesses that opened this year as well as opening in the near future, adding new job

opportunities for Madera County residents. The retail sector has been very dynamic with the introduction of well known and popular eating establishments, as well as the conversion of existing retail establishments to other uses showing strong demand. Madera County clearly has the diversified economic base to maintain a strong economy in spite of challenges out of our control.

I would like to thank Bobby Kahn, the Executive Director of the Madera EDC, for his great service to the Commission over the last 20 years. Bobby has been relentless since the day he stepped into this role by advocating for the growth of the economy by aiding the expansion of existing industry as well as introducing new businesses to Madera. Best wishes to Bobby as he transitions to other projects he has lined up. I also welcome Darren Rose as he assumes the role as the new EDC director. Darren has an extensive background in government related ventures and private industry that makes him uniquely qualified to tackle this opportunity. And finally, I would like to thank Madera County business owners, investors, and employees for your commitment to make our county a great place to live, work, and recreate. God Bless!



## CalRecycle's Recycling Market Development Zone (RMDZ)

CalRecycle's Market Development Zone (RMDZ) program combines recycling with economic development to fuel new businesses, expand existing ones, create jobs, and divert waste from landfills. This program provides attractive loans, technical assistance, and free product marketing to businesses that use materials from the waste stream for their manufacturing. To participate, a business must be located in a RMDZ Zone. All of Madera County is a RMDZ zone, so businesses within the county automatically are given the opportunity to benefit from the RMDZ program.

#### **Foreign Trade Zone**

A U.S. Foreign Trade Zone is a designated area that is, for Customs purposes, considered to be outside of the United States. Nearly any imported merchandise can be brought into a Foreign Trade Zone duty-free.

#### **Opportunity Zones**

Are federal economic development toll aiming to improve the outcomes of distressed communities. They offer tax incentives to groups who invest and hold their capital in zone assets or property for at least five years, and a permanent exclusion from a tax on capital gains from the opportunity investment held for ten years. Madera County has five designed census tracts included.


#### MCEDC Overview

- 3. To ensure a positive economic future to the residents of Madera County.






The vacancy rate is determined by the total amount of industrial units, total units occupied, and non-occupied units.

#### **NEW BUSINESS**



▲ Joe's Premium Car Wash This project is built from the ground up on a 1.5-acre site. The car wash is a 5,736-square-foot building. The site is located near the Save Mart Shopping Center on E. Robertson Boulevard in Chowchilla.



▲ Corsaro's Pizza Family-owned and operated for more than 20 years Corsaro's Family Pizza has moved and updated its Chowchilla site now open in the heart of the City's downtown.

ZND ZND is a world leader in the manufacturing of high-quality temporary fencing and barriers providing a safe, effective, and dependable crowd control solution. Madera becomes their first West Coast location, located in the Almond and Schnoor area.



▲ Boot Barn The western retailer has added one of their larger locations to the City of Madera with a 20,000 sq.ft. store.

Marlon Products A recreational outdoor product brand has chosen Madera as one of its 4 warehouse locations. Located on West Almond, you can find Marlonmade trailers and boats plus a range of reputable brands.



▲ Dutch Bros. Coffee has opened its first location in Madera County. This new location sits with Riverstone, a housing community located near the southwest corner of Avenue 12 and Highway 41.

#### **GROUNDBREAKINGS**



▲ WHSE Partners The newest multi-tenant industrial warehouse development located on South Schnoor Avenue is under construction. Upon completion, it is expected to deliver 144,000 square feet, (74 units of 1,950 sq. ft.).



▲ Cold Storage Facility Amond World, Origio Investments, and Span Construction and Engineering broke ground on their stateof-the-art refrigerated cold storage facility to specifically support farmers and processors.

#### **COMING SOON**



▲ The Margaux The 5,000 sq ft wedding venue located on Avenue 14 has begun construction and is expected to be completed by the Summer of 2023.

Big Lots The retail company Big Lots is headed to the Country Club Shopping Center, occupying the old Save-Market Supermarket location.

In N Out The fast food retailer proposes a Madera location. This will be the first Madera location and is to be located in the Marketplace Shopping Center.

AutoZone has announced Chowchilla, CA as the location for their newest distribution centers. Construction is expected to begin in 2023 and to be completed and ready for business in early 2024.

O'Reilly's Auto Parts In Chowchilla, CA, construction has begun on the auto parts newest site, located in the Dollar General Shopping Center, and is expected to open to the public in mid-2023.

#### **HOUSING**



▲ Esperanza Village The multi-million-dollar project was a collaboration between the City of Madera, The Pacific Companies, and MORES, funded by a grant from the California Strategic Growth Council.

Rancho Calera is a master-planned development in Chowchilla, California. Rancho Calera includes a nearly 13-acre park at the heart of the community, plus 7 neighborhood parks, and more than 5 miles of a "greenway network" that includes trails, pathways, and a broad central promenade to bring homes, schools, parks, and retail centers together.

#### **HEALTHCARE**



▲ Valley Children's Hospital Becker's Hospital Review Names Valley Children's One of Nation's Top Places to Work in Healthcare.



▲Tesoro Viejo Camarena Health Tesoro Viejo is under construction and expected to be ready to serve the community in early 2023.

#### **EXPANSIONS**

Certainteed Saint-Gobain, a French company through its building products subsidiary CertainTeed, is investing \$32 million to upgrade equipment at its insulation plant. With its new equipment and repair the plant is expected to consume less natural gas and electricity, reducing the plant's carbon footprint by more than 4,000 metric tons per year.



A Camarena Health Center has debuted its latest Almond Campus expansion. The Almond Avenue location provides a full range of services that include family practice, women's health, behavioral health, health education services, general dentistry cosmetic dentistry, and pediatric dentistry.

#### **PUBLIC IMPROVEMENTS**



► FWY 99 Expansion The \$89.1 million project revitalized approximately 23.4 lane miles through the City. Additional improvements included the construction of 11.7 new lane miles, an upgraded Almond Avenue on-ramp, the installation of 3,500 feet of drainage systems, five maintenance vehicle pullouts, a changeable message sign, and 25,000 feet of new concrete barrier. About \$66 million of funding for the project came from Senate Bill 1, the Road Repair and Accountability Act of 2017.

#### Sustainable Transportation Planning Grant

Madera County has been awarded \$450,000 from the California Department of Transportation (Caltrans). The award will be used to develop a Transit Area Specific Plan that will establish a vision for the phased implementation effort to relocate the San Joaquin's Madera Station and construct the adjacent future High-Speed Rail (HSR) station



▲ Fire Station 3 The latest addition to Madera County broke ground. The station will be designed with spaces to separate firefighter living and sleeping areas from the equipment and apparatus to protect firefighters from harmful contaminants. The station is expected to be completed by March 2023.

▼Fire Station 58, located adjacent to the municipal airport, unveiled its unit to the public with a ribbon cutting, celebrating the "Peoples Station."


